RE: SLDBE RE-CERTIFICATION

Dear Mr. Hurst:

We are in receipt of your re-certification application to the New Orleans Aviation Board to be re-certified as a State & Local Disadvantaged Business Enterprise (SLDBE) under our state and locally funded program. The result of our review of your application is that *Olympic Commercial & Residential Repair, L.L.C.* is recertified for a period of two (2) years, expiring **August 26, 2012**. Please note that your firm's certification will also be recognized by all DBE programs administered by the City of New Orleans, Sewerage & Water Board of New Orleans and Jazz Casino Company d/b/a Harrah's New Orleans Casino. This includes all entities receiving federal transportation funding within the boundaries of our state.

Your specialty will be listed in the next Certification Registry as:

commercial and residential construction; renovation; and new construction

Your participation on NOAB contracts will be credited toward SLDBE goals in your area of specialty. Requests for expansion of certification must be submitted to this office along with all documentation necessary to establish a justification for such expansion. It is the obligation of *Olympic Commercial & Residential Repair, L.L.C.*, to notify this office, in writing, if there are any changes in ownership and/or control of your firm. Any false information submitted on your application will be considered grounds for de-certification and/or prosecution. In the event of a third-party challenge to your eligibility status, this office will conduct an extensive review in response.

A **re-certification** letter will be mailed to you four (4) weeks prior to the date of expiration. **However, should you not receive notification from this office for your re-certification, it is your responsibility to contact us.** Submittal of this information is necessary to ensure that there is no interruption in your certified status during the two-year period. If this information is not received, we will proceed with decertification procedures.
